## DIAA Board of Directors' Meeting Minutes December 8, 2005 John W. Collette Education Resource Center

## I. Opening

A. Call to Order

The meeting was called to order at 9:12 a.m. by DIAA Chairperson Mark Holodick.

C. Approval of Agenda

Code 1009.2.4 and Item III. C. Request for Waiver of 14 DE Admin. Code 1009.2.4.2 for A.M. was being added to the agenda. Ms. Wilbur made a motion to approve the agenda as amended. The motion was seconded by Mr. Kee and carried unanimously.

- III. Action Items
  - B. Consideration of Appeal by A.M. of Eligibility Status Under 14 DE Admin. Code 1009.2.4

Dr. Kevin Fitzgerald; principal for Caesar Rodney High School, Mr. Nick Rodriguez; attorney for student, C.M.; mother of student, A. M. Sr.; father of student, and A.M. were in attendance to present this request. The student and parents requested a closed hearing. Dr. Hawtof made a motion to go into executive session because the student requested a closed hearing as an exception to the freedom of information act for

protection pupil files. The motion was seconded by Mr. Reed and carried unanimously. Mr. Williams made a motion to go into deliberation at 10:50 a.m. The motion was seconded by Dr. Sole and carried unanimously. Mr. Kee made a motion to come out of deliberation and go back to public session. The motion was seconded by Dr. Hawtof and carried unanimously. Mr. Kee made a motion to deny the appeal because the actions were based to obtain unfair athletic advantage which relates to rule 2.4.6. The motion was seconded by Dr. Hawtof and carried unanimously. Mr. Allen made a motion that the school did not establish sufficient evidence of a hardship based on 9.2.1 therefore the hardship rule would not be granted making student ineligible. The motion was seconded by Mr. Kee and carried unanimously. **Mr. Robinson was not present during this vote.**

Mr. Charles commented that he has had conversations with Pat Gallucci regarding Regulation 1008.2.7 Eligibility, Years of Participation. Mr. Gallucci expressed his concerns with this rule and was proposing to take the word consecutive out of this rule. He explained that in his school if a sixth graders fails he/she will not be eligible to participate in their eighth grade school year and feels this rule should be changed to allow the student to participate during their eighth grade. Mr. Gallucci commented that he felt that this rule was intended to stop students from using an extra year of athletics but feels now it takes away from students. Mr. Holodick commented that the Board will take this presentation into consideration.
