G. Strategic Plan Update

Mr. Rex Varner provided an update on the Strategic Plan. The update focused on guiding principles, priorities and activities over the next several years, feedback received from stakeholders and what the implementation plan would look like.

H. Football Classification Update and Member School Application Request to Change Football Classifications

Mr. Dave Collins and Mr. John Wilson from DAAD's Football Subcommittee presented recommendations to the board for the following schools to change football classification. The board heard rationale (50% enrollment/50% winning percent) for the recommendation to move a school from one classification to another and recommendation on applications received.

Class 3A recommendation

- Saint Mark's to move from 2A to 3A D1 using the data model of 50% enrollment/50% winning percentage. Saint Mark's had the highest ranking based upon the data model (winning %, avg roster size, playoff victories and head to head victories of the four teams considered – Newark, Howard, Saint Mark's, Sussex Tech)
- St. Georges volunteered to move from 3A D1 to 3A D2 to balance district schools

Class 2A recommendations

• The recommendation rationale is based on the 18 team model approved by the board in June.

- The following 2A schools AI duPont, Brandywine, Conrad and McKean applied to move from 2A to 1A
- Odessa applied to move from 1A to 2A based on increased enrollment size projected for 2023-24
- Laurel to move from 1A to 2A using the data model of 50% enrollment/50% winning percentage. Laurel had the highest ranking based upon the data model (winning %, avg roster size, playoff victories including a state championship of the three teams considered – Charter Wilmington, Seaford, Laurel)
- Caravel and Red Lion to move from 2A D3 to 2A D1 to balance district schools
- Odessa to move from 1A to 2A D2
- Laurel to move from 1A to 2A D3

I. DIAA Track Committee Request to Extend 2022 Competition Season

Ms. Donna Polk shared recommendation to the Board from DIAA Track Committee to extend the track season after DIAA Indoor Track Championships due to date available for 2023 by Prince Georges Sports and Learning Complex (PGSLC). With the new staff change at PGSLC, the previous date later in February was not awarded.

III. 2022 Volleyball Quarterfinal Games Change of Venue for November 8, 2022 Games

Ms. Polk answered questions from the board and provided an update on rationale for decision to change sites with student athlete wellbeing as the focus. Discussion occurred on number of meetings for volleyball committee, which rounds schools should host vs neutral sites, schools willing to host and the growth of volleyball throughout the state.

IV. DIAA Committee Updates

Officials Committee Meeting – Mr. Bell provided update. The revised charge by the Board was shared with the committee members and how the revised charges will be approached. The officials fees were discussed. Ms. Polk reminded the committee of the fees schedule the board approved and the Board seeking recommendation from Officials Committee if current approved fees schedule will remain or if a revised fees schedule will be recommended. Also shared with the committee the board does not want to be involved in negotiations and the purpose for the revised charge includes streamlining processes and providing consistency with committees.

Mr. Thompson asked for follow up on Mr. Gunns application. Mr. Bell shared the committee requested additional information. Mr. Thompson shared he was not happy and would discuss at Monday's meeting.

Baseball Committee Meeting – Mr. Bell shared the committee reviewed criteria for selection and removing the .500 record requirement and changed the bonus points from .701 to .667 to reflect number of max games from 20 to 18.

Swimming Committee Meeting – Mr. Bell shared the committee discussed championship schedule and general operations for the tournament. No changes.

Field Hockey Committee Meeting – Ms. Polk provided update of the championship dates change for 2023. Athletic directors are not in support of the date change and prefer to occur during new schedule cycle and expressed concerns with shorter season. Committee will meet again for me to share the concerns expressed by athletic directors.
