SESSION ONE – FRIDAY, FEBRUARY 27, 2026

1. Weigh-In/Admission Set Up
 - SWC Set up weigh-in area by 1:30
 - Teams arrive 2:00 p.m. (no earlier)
2. Weigh-in held in the weight room at 2:30 p.m.
 - Weigh-ins conducted in order of weight class starting with 106.
 - Wrestlers must present when their weight class is called.
 - Wrestlers failing to make weight on first attempt may step on all other scales one time prior to the conclusion of that weight class.
 - A committee member will stamp the wrestler's hand for admission.
 - Coaches are to turn in Skin Check form verified by school's ATC. Coaches must present doctor's notes for skin conditions to the Tournament Director prior to weigh-ins. Wrestlers must pass a skin check.
