In this case, the school responds sensitively and proactively by prioritizing the teacher student/relationship allowing the student to remain within their original class; continuing to make solid progress versus removing.

Due to the detrimental implications of staffing beyond unit count, we staff our buildings as of the first school day based on our $98 \%$ guarantee. This year, that meant there were four units we earned that weren't filled until November/December. Adding teachers after the $9 / 30$ unit count is certified, to lower class size, is not an option as the qualified applicants are no longer available and parents do not approve of changing their child's teacher mid-year. We also return some units as part of our state reduction plan.
