1 GETTING ONLINE

All school districts and Birth to Three Early Intervention Program (B23) have their own online ASQ portals for community access to complete developmental screenings. A list of all portal links and contacts is available in the appendix of this manual. If your district's contact person has changed, please update the ASQ Technical Assistant annually, or as soon as possible to make changes in your district's portal.

There are 3 introductory trainings you should take as a prerequisite to using the ASQ System (there is no fee for these trainings):

1.2 ASQ ONLINE: A BRIEF OVERVIEW



At the top of each ASQ Online web page you will find the top navigation menu. This menu will take you to the different sections of ASQ Online, including your Home page, My Profile, Program, Child Profiles, Screening Management, Reports, and Family Access.

A brief description of each page is provided below:

- **Home:** Access Child Profiles, Screenings, and Help items from this page, which is customized to your role as Program Administrator.
- **My Profile:** View and edit your profile information, change your password, create and manage your personal notes and files, manage your user access, and create personal alert messages regarding various functions in ASQ Online.
- **Program:** Find information regarding your program, add program users, add custom tasks, import and export data, and set your screening preferences.
- **Child Profiles:** Manage all Child Profiles within your program, assign users to children, and view individual screenings.
- Screening Management: Schedule screening tasks and non-screening tasks, generate and print screening and follow-up materials, create your own program-specific documents and groups of documents, and keep track of the status of scheduled tasks for all children in your program.
- **Reports:** Generate program-specific reports.
- Family Access: Create and manage your Family Access web page used for online questionnaire completion, and accept or reject screens that have been submitted to you through Family Access. (NOTE: This is an optional module that requires an additional subscription.)

2 PARTNERING WITH COMMUNITY EARLY LEARNING PROVIDERS

Child Care Centers, Head Start Programs, Family Child Care Programs, and Private Preschools

Partnership Agreements are not required, however they will assist in managing the expectations between the districts and early childhood programs. (see appendix for sample).

- 2.1 PREPARING YOUR OUTREACH MATERIALS
- Set up your website so the following information is easily accessible:
 - o ASQ Links
 - Consent to Screen on district letterhead
 - Invitation Letter on District letter head (see appendix)
- Check to make sure Consent to Screen form matches the updated wording on the ASQ Platform. It should read:

Screening results will also be shared with your child care provider, because they must keep track of completed developmental screenings (required by Delaware Stars for Early Success) and your district of residence if there is a concern."

- Create a flyer with your district's online screening access info.
- 2.2 OUTREACH ACTIVITIES
 - Send flyer along with your Consent to Screen and Invitation Letter, both on district letterhead, to child care programs within your district inviting them to participate by using your district's portal.
 - Visit the link below to determine which child care programs are in your district:

- This resource allows users to filter the list of child care programs by school district. An excel document can be created from the results by clicking the three dots and choosing "Export to CSV file".
- This resource also provides the child care program's Star level, Address, and Phone Number.
- Send an email blast with the screening flyer, Invitation Letter, and Consent to Screen to all child care programs in your district by contacting Betty Gail Timm at the Office of Child Care Licensing (OCCL) at Elizabeth.Timm@doe.k12.de.us
- Consider having a meeting with providers in your district to discuss the ASQ process and answer questions.

- Provide a certificate to attendees as this will count towards their 18 hours of training required by OCCL. Follow OCCL's community-based training for professional development requirements.
- Create a schedule with child care programs in your district, if possible, to avoid a high volume of screenings at any one time.
- Partnering with Elementary Schools in your District:
 - Meet with secretaries, principals, and Kindergarten teachers to explain the importance of developmental screening and request they distribute screening flyers to families with young children.
 - Provide extra copies to sites to make available for families.
 - Request that the school consider adding the screening links to their websites.
- Partnering with community programs in your area:
 - Contact local libraries, Parents as Teachers, medical centers, Police Athletic League (PAL) centers, Boys and Girls Clubs, YMCA's, etc. to explain the importance of developmental screening.
 - Provide extra copies of the screening flyer to community partners and ask them to share with families with young children.
 - Consider joining a Delaware Readiness Team in your area as they are actively involved in promoting access to Developmental Screening for ALL children.

2.3 ADDING NEW CHILD CARE PROGRAMS

It is possible that new child care programs will need to be added to the ASQ Enterprise Account as providers. You are no longer responsible for adding new programs to your portal. Please follow the process below to register new programs:

3 REVIEWING SCREENINGS AND TRACKING REFERRALS

- Developmental Screenings MUST be reviewed <u>at least</u> once every 2 weeks.
- Check both Family Access and transfer history report to get most recent screenings.
- Flexibility is permitted during high rates of screening, such as the fall.
 - Keep in mind the Head Start Performance Standards which notes a 45 day screening timeline.
 - Check with your district leadership to determine if an MOU with your local Head Start program exists. This may indicate that you must meet the 45 day standard noted above.
 - If an MOU is in place, screening for Head Start programs will be given priority to meet the standards.
- If you receive a screening from a child under 34 months, place that child's screening into the ASQ Technical Assistant's (Jenny Grady) classroom to be transferred.
- If you receive a screening from a different state (outside of Delaware), and the child does not attend a child care in Delaware, reject the screening so the family receives automated rejection notification email.
- If the child is attending Delaware child care but resides in a neighboring state, you may accept the screening, share results, and direct them to home state for IDEA entitlement. Do not evaluate children out of state; refer them to their home state for evaluation.
- Screenings are completed based on the location of the child care, not parent's district of residence.
 - If referral is needed and the child resides outside of your district (and your district is not participating in the New Castle County Memorandum of Understanding (NCC MOU), refer to the appropriate district using their Child Find email listed in the appendix. Permission is included in online consent and written consent form.
 - If your district is participating in the NCC MOU, and the child resides out of district but attends child care within your district, your district is responsible for completing the referral, evaluation, and services if appropriate.

3.1 ACCESSING SCREENINGS TO BE REVIEWED

To view all screenings that have been submitted through Family Access:

- 1. Select Family Access from the top navigation menu.
- 2. Click the link that says, "You have [#] family access screenings to approve (or reject)."

You will be taken to a list of all screenings that have come in through Family Access. Each child has their own drop-down box that includes their name, the caregiver, the questionnaire, the screened date, and the completed date. If you click the *Preview* link, you can view the demographic data as well as the number of items that were answered for each area. Click the arrow icon to the left of the child's name to bring up the accept/reject options.

To view all screenings that have been transferred to your portal, run the Transfer History Report:

- 1. Select *Reports* from the top navigation menu.
- 2. Click on the report named Transfer History.
- 3. Click *Generate Report*. The page will display a "report status" while the report is being processed.
- 4. Three report generation options will appear: *Download PDF, Download CSV,* or *Preview Report.* Select the report generation option that you would like to run.

3.2 REVIEWING SCREENINGS

You are responsible for reviewing screenings that come in through the Family Access Portal and Transfer History Report.

3.2.1 Accepting a Screening within Family Access Portal:

You only need to accept screenings that are submitted through Family Access Portal. Screenings on the Transfer History report have already been accepted to the portal and need to be reviewed and processed.

1. Sign in to the ASQ portal and click Family Access tab.

Under public URL's, it notes how many screenings to approve/reject or assign.

- 2. Click on Preview to check to see if the child has an assigned child care/preschool.
 - a. If there is an assigned child care/provider, this will be who you assign as the provider.
 - b. If there is no assigned child care/provider, select accept without assigning to provider.

Accept/Reject Options:

If you choose "**Accept and attach to an existing child profile**," a text box will appear, prompting you to start typing a child's name to search. Begin to type the child's name. You will see a drop-down menu of suggestions for the child you are looking for. Select the child and click the *Process* button. This screening will be added to the Child Profile you have selected.

If you choose "**Accept as a new child profile and assign to provider**," a drop-down menu will appear with a list of Providers in your program. Select the Provider you wish to assign this child to from the drop-down menu, and click the *Process* button. This child and his or her screening will now be a part of your program.

If you choose "Accept as a new child profile without assigning to a provider" and click the *Process* button, the screening will remain in a pending status until it has been assigned to a Provider. (See Section 10.9 Assigning Pending Screenings to a **Provider** for more information.)

If you choose "**Reject entirely**," the screening will not be included as part of your program and you will not have access to the data on that questionnaire. ***DO NOT USE**

The option to "**Reject entirely and notify the caregiver via email**" will only be available if that child's caregiver chose to include an email when they submitted the Family Access screening. If you choose this option the screening will not be included as part of your program and you will not have access to the data on that questionnaire. The caregiver will be emailed a generic letter informing them that the screening was not

- 3. Click process
- 4. Merge Child Profiles so there will be only 1 profile for each child.
 - If for any reason you have duplicates of the same Child Profile, you can merge those profiles together to create one Child Profile, without losing the data from either profile.
- 3.2.1.1 To Merge Child Profiles:
 - 1. Select *Child Profiles* from the top navigation menu.
 - 2. Select the name of a Child Profile you wish to merge.
 - 3. In the Child Profile Details section, click the Merge tab.
 - 4. You will be taken to a list of Child Profiles within your program. This page lists the child's name, DOB, Child ID, and Alt. ID. Any rows that are bold indicates a child profile with the same birth date or name.
 - 5. Select the button to the left of the Child Profile that you would like to merge.
 - 6. Click the Merge Child Profiles button at the bottom of the page.

Please note that when merging two profiles, the Child Profile that you are merging *into* is the data that will prevail. If the merging profile has separate demographic data than the profile being merged into, the demographic data will be overwritten.

Once two child profiles are merged, the merged child profile will be available to view under the Quick Link, *Recent Merges*.

Assigning multiple children to a Provider (typically used when assigning a provider from the transfer report):

- 1. Select Program from the top navigation menu.
- 2. Select Search Program Users from left Quick Links menu.
- 3. Click on the name of the user you want to assign child profiles to.
- 4. Click Assign Children to Provider from left Quick Links menu.
- 5. Click in the box to the left of the child profiles that you want to assign to the user in the Available Child List section.
- 6. Click Add.

Those selected child profiles will now be assigned to that provider user.

- 3.2.1.2 Assigning a Provider or Reviewer to a Child Profile:
 - 1. Select *Child Profiles* from the top navigation menu.
 - 2. Select the child to whom you wish to assign a Provider or Reviewer.
 - 3. Scroll down to the Child's Providers & Reviewers section.
 - 4. Click the Add tab to the right of the Child's Providers & Reviewers tab.

OR

- 1. Click the Add Provider/Reviewer Quick Link.
- 2. You will be taken to a **Providers & Reviewers** page where you have two options:
 - a. Search for available Providers or Reviewers by "Program user last name" or "Program user first name."
 - b. Scroll down to the Available Providers and Reviewers section, and look for available Providers or Reviewers by last name.
- 3. Click the *Add* tab in the top right corner of the Available Providers and Reviewers section. You will get a message saying, "User was successfully assigned to child profile."

3.3 REVIEWING AND PROCESSING SCREENINGS

After the screening has been accepted to the portal (either through Family Access or Transfer History), you must review and process the screening to finalize this activity. There are 3 steps to completing this:

- 1. Completing the Screening Summary Sheet
- 2. Sending results to families
- 3. Entering a Child Profile Note

3.3.1 Completing the Summary Sheet

Completing the Follow Up section on the summary sheet is imperative for data collection efforts.

This is section 4 on the Summary Sheet. Data is being collected on the 3 follow up activities below. Choose at least one of these 3 options (click all follow up actions that apply):

- o Share Results with primary healthcare provider.
- Refer to early intervention/early childhood special education.
- No further action taken at this time.

Click "Save follow-up actions".

ASQ:SE-2 Follow Up:

This is section 5 on the Summary Sheet. Although data is not currently being collected on the ASQ:SE-2, consider using at least one of these 3 options (click all follow up actions that apply):

- Refer for early intervention/early childhood special education.
- Refer to social-emotional, behavioral health, or mental health evaluation.
- Other- add note "No further action taken at this time".
- 5. FOLLOW-UP ACTION TAKEN: Check all that apply.



Click "Save follow-up actions".

3.3.2 Sending Results to Families

- Determine if the screening is "on target", "needs monitoring", or "referral" and send the appropriate Parent Results Letter via email along with ASQ activities for Home and CDC Developmental Milestones Booklet
 - Information is found at:

- If an email does not exist for the family, share the results with the child care/provider and ask them to share with the family or mail the results.

- If the screening has no child care/provider and the family has no email address, it is permitted to send a copy of the letter, the screening results and the resources via mail, to the family.
- If family does not respond to the letter when further evaluation is recommended:
 - If family does not respond to letter when further evaluation is recommended, contact family by phone to review screening results.
 - Consider sending a follow up email and make several attempts at connecting with the family within 2 weeks of initial attempt.
- If a child care provider completed the screening:
 - Share the results with the provider and ask them to share results with the family.
 - Add a child profile note indicating "referred to child care to discuss results with family".
- If 1 of the 2 screeners were submitted, you may wait until both screeners are completed before processing. Consider reaching out to the child care to request they follow up with the family to complete the missing screening.
 - If ASQ-3 was submitted without ASQ:SE-2, consider processing the results (especially if a referral may be recommended) and send the ASQ:SE-2 link with results. If the ASQ:SE-2 is not submitted in a timely manner or with multiple attempts to request completion.

Completing the Results Letters:

If using the results letter template from the appendix, follow the procedures below.

- 1. **On Target**: If both screenings are on target, fill out form as noted below
 - a. Box 1: Check areas indicating the child was on target.
 - b. Box 2: Check no additional action by parent is needed. Use attached packet as a guide to support your child.
- 2. **Needs Monitoring:** If both screeners are completed and any area is in monitoring range, fill out the parent results form as noted below:
 - a. Box 1: Check the boxes indicating where the child's screening fell in each area.
 - b. Box 2: Check the box which notes "Implement the attached "Activities for Children" based on your child's age. Continue to monitor your child's skills. If you have any concerns, contact Child Find."
 - i. Consider referral to 211/Help Me Grow to assist with addressing underlying social determinants of health.
 - ii. Consider referral to physician.
 - iii. All decisions are made on an individual basis with parent input.
- 3. At Risk: If both screeners are complete, and any area is below target, fill out the parent results form as noted below:

- a. Box 1: Check the boxes indicating where the child's screening fell in each area.
- b. Box 2: Check box indicating "Some scores might warrant further educational evaluations for early intervention services or special education services." Contact Child Find.

Further Assessment or Referral does not always mean a full diagnostic evaluation. Additional Child Find activities may be initiated by the district to determine evaluation or resource needs and are based on individual need. Consider Referring to 211/Help Me Grow or Physician.

3.3.3 Entering a Child Profile Note

Entering a child profile note is helpful for the providers to know the preliminary steps for follow up. Here is where you would note if you made contact with the parent, what your recommendations were based on the screening, and if the referral was made. Items to include in child profile note:

- Results and recommendations sent to the family.
- If a referral was made.

To add a Child Profile note:

- 1. Select *Child Profiles* from the top navigation menu
- 2. Browse the Child Profiles list or search for a Child Profile.
- 3. Click on the child's name to access his or her profile.
- 4. Click on the *Add* tab next to the Child Profile Notes tab.

OR

- 2. Select the Add Note Quick Link.
- 3. On the Add Note page:
 - a. Enter the "Subject" of the note.
 - b. Select the "Note type" from the drop-down menu. Your options are: Reminder, Medical History, Family Status, Referral, Assessment, Intervention, Observation, Concern, Program Status, and Other.
 - c. Enter the text of the note in the "Description" text box.
- 4. Click Save.

4 TRACKING REFERRALS

The state is still determining how referrals will be tracked.

5 MY ALERTS

As Program Administrator, you have the ability to set up personal alert messages regarding various ASQ Online functions, which can be sent via text message or email. These messages can be task reminders, Family Access alerts, or transfer alerts. In addition, you can select your preferred time zone that will be used when you set alerts scheduled at a specific time of day.

- Standard text messaging rates apply to each text message alert received as provided in your wireless rate plan (contact your carrier for pricing plans and details). Email alerts will be subject to standard Internet access and usage charges imposed by your Internet service provider.
- If you choose to receive both an email and text message alert, you don't have to receive them both at the same time. You can customize the day and time you wish to receive each one.
- If you have selected to be alerted via text message, you must have a mobile phone number saved in your profile.

7 ARCHIVING A CHILD PROFILE (KINDERGARTEN)

Archive screenings for children entering kindergarten at the end of the school year.

- Go to Reports and choose Screening Status Summary. Run a report for screening intervals 48, 54, and 60 months. Make sure the child is eligible for Kindergarten prior to archiving.
 - This report will provide the names of the children you need to archive.
- Child care programs may also contact you to archive children in order to keep their classrooms up to date.
- If a child leaves your program, you may wish to archive the child's profile, so you can control whether or not the child shows up in your reports.

By archiving a Child Profile, you are removing that child profile from any assigned providers. An Archived child profile cannot have screenings, tasks, etc. added to the profile. The Program Administrator will still have access to the child profile from the Archived tab within the Child Profiles section. The Program Administrator can also continue to include Archived child profiles in reports by selecting "All", or "Archived". Marking a child as "Archived" does not delete that child's profile, and you can mark the child as "Active" again at any time by selecting the Archived tab of the Child Profile list.

By deleting a Child Profile, you are permanently removing the child and all of his or her associated notes, tasks, screenings, and caregivers from the ASQ Online system. You will not be able to include this child's tasks or screenings in any reports you may run. Once you delete a child's profile, you will no longer have access to his or her profile information or screening results. *Please delete Child Profiles with caution.*

As part of this service, we provide the Ages & Stages Questionnaires, Third Edition (ASQ-3), and the Ages & Stages: Social Emotional 2 (ASQ:SE-2) to help you keep track of your child's development.
