Resource 1: Trouble in Tyranny

Tyranny is a mythical island located in the Atlantic Ocean. Until recently, no one knew about it. Just this month, a young man from Tyranny named Vick Tim was spotted floating in a small boat just off the coast of Delaware. He told the people who rescued him that he escaped from Tyranny.

Vick is now telling everyone about what has been happening in *Tyranny*. We have learned that the island is named after its king who is a tyrant (pronounced "fle-rant"). A tyrant is a person who is mean and abuses power. The "Tyrant King," as he is known, does things that are very unfair to the people of *Tyranny*.

You are about to read about things that the Tyrant King does. Your task is to come up with some rights that the people of Tyranny should have so that they can be protected from the Tyrant King. A right is something that is guaranteed to you - something that you are legally allowed to have or do. Rights are things that normally cannot be taken away.

Vick Tim wants to return to *Tyranny* and start a rebellion against the Tyrant King. And he plans to get other people in *Tyranny* to support him by showing them the list of rights that you come up with. If the rebellion succeeds, everyone in *Tyranny* will be given those rights.
