

**DELAWARE DEPARTMENT OF EDUCATION
STATE AGENCY ADMINISTRATIVE REVIEW SUMMARY**

During one week of the review month, insufficient vegetable subgroups were served. Only 3/8-cup of dark green vegetables were offered (the requirement over the course of the week is 1/2-cup).
