

**DELAWARE DEPARTMENT OF EDUCATION

Finding(s) Details: Insufficient daily quantities of fruit were served at breakfast during the month of review. Insufficient weekly quantities of fruit for the age/grade group were served. Juice exceeded the 50% maximum for the week of review. Production records did not reflect the appropriate meal components/quantities for the age/grade groups; some production records were incomplete. There were insufficient daily and weekly quantities of meat/meat alternate provided at lunch during the week of review. There were insufficient daily and weekly quantities of grains provided at lunch during the week of review. There were insufficient fruit quantities offered on one day during the week of review which also caused insufficient weekly quantities for the 9-12 age/grade group. There were insufficient quantities of vegetables offered on nine days during the month of review. There were insufficient quantities of fruits offered on three days during the month of review. Offer versus Serve (OVS) was not implemented correctly at breakfast.
