Dear Charter School Accountability Committee,

On behalf of the Community Education Building, I am writing to express our support for Great Oaks Charter School in their application for a renewal of their charter. As the CEO of the Community Education Building since the 2016-2017 school year, I have observed and supported a school that has maintained as its highest priority the welfare and education of their students. At Great Oaks, a student is not just a number or a data point, but an individual with a voice and a purpose.

This unrelenting focus on, and commitment to, Wilmington's youth is the reason that, despite some extraordinary conditions and events, Great Oaks has continued to serve their students. Having been a school leader myself, I can confirm that the easiest path for the board and leadership over the years would have been to walk away. But they did not walk away. They became stronger. As a result, the school is now thriving, and students are experiencing a sense of belonging and purpose.

The current school leadership has ushered in tremendous improvement in student and staff culture. This is reflected in dramatic improvements in attendance and student engagement. It is also reflected in a very tangible way when you walk into any classroom and see an energized teacher facilitating learning with highly engaged students who are asking clarifying questions, seeking deeper explanations, and experiencing the joy of learning. Not surprisingly, this has led to a significant reduction in school incidents.

Great Oaks serves resilient students who come to school with significant trauma, many of whom are self-raised and/or are raising siblings and living in some of the poorest areas of the city. Thirteen percent (13%) are justice-involved, and thirty seven percent (37%) have IEPs. Despite the high level of support needed, the teachers and leaders are meeting the needs of students through targeted school-based and community-based support, and students are thriving in the small and intimate school environment where they have access to personalized support. Most remarkably, they are accomplishing this with a viable balanced budget.

CEB has and will continue to walk alongside Great Oaks to provide additional resources and opportunities to their students and families through authentic collaboration with the school staff. Our Family Resource Center programs and resources and the Student Advocacy System provide added assurance that students have what they need at school and at home to reach their potential. We remain committed to supporting the success of Great Oaks' students through ongoing collaboration with grant writing, shared partnerships, and school-to-community connections.

Great Oaks may not fit the traditional model for a public school in Delaware, but there is little question that the school is on an upward trajectory and is providing a much needed and desired learning experience to youth and families in Wilmington. Wilmington's youth need Great Oaks Charter School to remain open.
