**Supply Chain Assistance Funds – Round 4**

This memo is being sent to announce the distribution of the fourth round of Supply Chain Assistance (SCA) funds to School Food Authorities (SFAs). These funds are being distributed to assist SFAs with the challenges of supply chain disruptions in obtaining food for the School Breakfast Program (SBP) and National School Lunch Program (NSLP). The United States Department of Agriculture (USDA) recognizes that due to supply chain disruptions, SFAs may have had to “significantly revise planned menus, popular and previously available food items may have become more difficult to procure, and in some cases shortages and price fluctuations have made it difficult to provide meals that are appealing to students and meet the NSLP/SBP nutrition and meal pattern requirements” and is providing this funding to help with these types of issues.

The SCA funds will be deposited into the nonprofit school food service account and can be used for domestic food purchases that are unprocessed or minimally processed. The funds may not be used for labor, supplies, or administrative expenses. Each SFA will receive a \$5,000 base payment and a proportional funding amount based on SFA enrollment. Allocations are attached to this memo for your review.
