Positive Outcomes Charter School

Charter Renewal Final Report November 28, 2023 On September 30, 2023, Positive Outcomes Charter School (Positive Outcomes) submitted an application to renew its charter for a term of five years. The purpose of the final meeting is for the Charter School Accountability Committee (CSAC) to review the renewal application in light of the relevant statutory criteria for renewal.

This report serves as a summary of the strengths, areas of follow-up and/or concerns identified by members of the Charter School Accountability Committee (CSAC) during their review of the charter applicant's renewal application, performance review reports, annual reports, and performance agreements and during CSAC meetings.

- The Secretary of Education will announce his decision at the December 14th State Board of Education meeting and ask for the assent of the State Board.
