ANNUAL REPORT ON CHARTERS

Report Overview

As required by 14 Del. C. § 514, the Delaware Department of Education (DDOE) prepares an annual report for the Governor, General Assembly, and State Board of Education on the success or failure of charter schools and proposes changes necessary to enhance or modify the charter school program. As required, this report contains:

- a comparison of the per student expenditures of charter schools, considering all funding sources;
- recommendations relating to Delaware education laws, in light of the content of the annual reports submitted pursuant to 14 Del. C. § 513; and
- the assessment of specific opportunities and barriers relating to the implementation of charter schools' innovations in the broader Delaware public education school system.

14 DE Admin. Code 275 further defines the requirements of this report to include an analysis of all charter schools in relation to the Performance Framework.

General Charter School Information



Charter schools are public schools that are designed and operated by educators, parents, community leaders, educational entrepreneurs, and others. They are chartered by local or state education agencies, which monitor their quality and effectiveness.

During the 2024-2025 school year, there were twenty-four charter schools in Delaware. Twenty-two of those charter schools were authorized by DDOE with the assent of the State Board of Education, and two were authorized by the Red Clay Consolidated School District. The 2024-2025 charter schools are listed below, along with their authorized enrollment and the year they opened.

Charter School Performance Frameworks

Charter schools are evaluated annually for their academic, organizational, and financial performance using three separate performance frameworks. The Delaware Performance Framework guiding documents can be found on the [DDOE Charter School website](#).

Delaware School Success Framework (DSSF)

Delaware operates under the belief that all schools benefit from continuous improvement – including those that receive exceeds expectations ratings – to best support all students. The Delaware School Success Framework (DSSF) outlines the accountability standards by which all Delaware public schools are measured. These state- and school-level data help identify each school's needs and guide determinations about how best to support students across the state. The DSSF measures the following areas to determine school success:

- Academic achievement – Proficiency for ELA and math (grades 3-8 and 11)
- Academic progress – Growth in ELA and math (grades 4-8); includes growth of the lowest and highest performing students in a school
- School quality/student success – On-track attendance (K-12), science proficiency (grades 5, 8 and biology), social studies proficiency (grades 4, 7, and 11), college/career preparedness (grades 9-12), and on-track in 9th grade
- Graduation rates – 4-year, 5-year and 6-year adjusted cohort graduation rates
- English language proficiency (ELP) – Progress toward English language proficiency (grades 1-12)

Organizational Performance Framework

The purpose of the Organizational Performance Framework is to provide each charter school and the public a useful annual assessment of the school's organizational soundness, public stewardship, and fulfillment of legal obligations. The Organizational Performance Framework seeks to provide information regarding these key questions:


- Is the school organizationally sound and well operated?
- Is the school fulfilling its legal obligations, fiduciary duties and sound public stewardship?
- Is the school meeting its obligations and expectations for appropriate access, education, support services, and outcomes for students with disabilities?

The overall Organizational Performance Framework is broken down into four metrics or indicators that include ten separate measures. These metrics/indicators and measures include:


1. Education Program
 - a. Mission Fidelity
 - b. Applicable State and Federal Requirements
 - c. Students with Disabilities (SWDs)
 - d. Multilingual Learners (MLLs)
2. Governance and Reporting
 - a. Governance and Public Stewardship
 - b. Oversight of School Management
 - c. Reporting Requirements
3. Students and Staff
 - a. Student Rights
 - b. Requirements on Teacher Certification and Hiring Staff
4. Facilities, Transportation, Health, and Safety

Financial Performance Framework

Charter schools have the autonomy to manage their financials consistent with state and federal law; however, authorizers must ensure that the schools they authorize are financially stable. Authorizers, by renewing or not renewing a charter school, determine whether that school is not only academically and operationally sound, but also financially viable.


The purpose of the Financial Performance Framework is to provide key data to assess the financial health and viability of charter schools and to determine whether deeper analysis or monitoring is required. Through a set of nine interconnected metrics, the Financial Framework analyzes the current state of charter schools while considering the school's financial trends over time. The measures are designed to be complementary; together, they provide a lens into a school's near-term financial situation, historic trends, and future viability.

The Financial Performance Frameworks are measured using the following indicators:

1. Current Ratio (Working Capital Ratio)
2. Debt to Asset Ratio
3. Days Cash
4. Debt Service Payments / Loan Covenants
5. Aggregate Three-Year Total Margin
6. Cash Flow
7. Debt Service Coverage Ratio
8. Enrollment Variance
9. Financial Management and Oversight



Recommendations and Next Steps

In alignment with the requirements of Title 14, Chapter 5 and 14 DE Admin. Code 275, the Department will continue to review Delaware's statutory and regulatory framework governing charter schools to ensure clarity, coherence, and administrative sustainability. Areas for continued review may include:

- Charter schools operate under a number of statutory and regulatory reporting requirements across Title 14, Chapter 5 and 14 DE Admin. Code 275. As independent LEAs, charter schools may have reduced central office staffing structures comparable to traditional districts, which can present unique considerations for administrative activities, compliance and reporting, and other monitoring obligations. Continued review of reporting structures and alignment of requirements will support efficient compliance while maintaining accountability.
- Continued review of Title 14, Chapter 4 and Chapter 5 is warranted to ensure consistent terminology, aligned definitions, and coherent statutory language related to public schools, school choice, and charter governance. Clarifying statutory alignment supports uniform interpretation and implementation across school types.
- As needed, the Department will continue to engage with the Public Education Funding Commission and related state funding bodies to ensure that public education funding structures appropriately reflect operational responsibilities and fiscal sustainability considerations across all public school models, including charter schools.
- The Department is in the process of developing an updated new charter school application aligned with Title 14, Chapter 5 and 14 DE Admin. Code 275, with the goal of improving clarity; consistency; and efficiency for applicants, reviewers, and decision-makers.
- Ongoing review of the charter application and authorization process, including Charter School Accountability Committee procedures, will focus on streamlining timelines; aligning application materials with performance frameworks; and supporting transparent, timely, and well-informed recommendations to the Secretary of Education and the State Board of Education, while maintaining rigorous statutory and regulatory standards.

- These activities reflect the Department's ongoing approach to charter school authorization, accountability, and oversight, and are intended to support clarity, consistency, and continuous improvement across Delaware's public education system.
